

The Deposit-at-call or Demand Draft must be submitted along with the tender.

Tender documents shall be issued on payment of Rs.1000/- (Rupees one thousand) only in cash through challan at cash section of AMC/ Demand Draft(Non Refundable) on any working days as specified above on production of documentary proof of registration of the firm along with an application.

Demand drafts furnished towards Earnest Money along with the tender shall be valid for a period of 3(three) months from the last date of receipt of tender or more.
