## TERMS of REFERENCE

### **A. OBJECTIVE:**

In order to improve the primary activities of Solid Waste Collection & Transportation it is decided by AMC authority to induct more number of community bins in the service so that indiscriminate littering & trashing of the waste may be eliminated and city may be kept clean, healthy and pollution free.

### **B. SUBMISSION OF TENDER:**

The Tender is to be submitted in two parts viz. "Technical Bid" & "Financial Bid". The bids would have to be submitted in separate sealed covers super-scribed respectively and both envelopes kept in a single envelope marked as "Solid Waste Collecting Equipment" and should be addressed to Executive Engineer (Mech.) Agartala Municipal Corporation, Mechanical Division, Ramnagar Road No-9, Agartala, Pin: 799001, Ph: 0381-23230010. The cover should clearly indicate the name of firm along with full address including phone no & e-mail ID.

#### Contents of the envelop superscribed as "TECHNICAL BID"

- EMD Rs. 1,44,000/- & Application Fees: Rs. 3000/- in the shape of DD(Nationalized bank only) in favour of Agartala Municipal Corporation.
- Organizational profile.
- Turn over Details.
- Valid VAT / Sales tax clearance certificate.
- Experience details (Work order supported with completion certificate).
- After sale service facility in detail.
- Whole tendered documents duly signed & sealed.
- Information as per **Annexure-I** in due order. (It will be utilized for evaluation of the technical Bid.).

#### Contents of the envelop super-scribed as "FINANCIAL BID"

- Price bid document as per **Annexure-II**.
  - (i) *Prices quoted must be firm and fixed for a period of at least one year. Variations and escalations will not be allowed.*
  - (ii) *The Bidders are required to furnish their offers in the price proposal both in words & figures. Correction if any shall be made by crossing out, initialing, dating and rewriting. (Any condition with regard to financial aspects, payments, terms of rebate etc beyond the prescribed financial terms of AMC will make the bidder invalid. Therefore it is in the interest of the Bidder not to write anything extra in the Price Proposal except the price.)*

- (iii) *In case there are two or more Suppliers quoting the same price for a particular item, AMC may in such case, call all such Suppliers for negotiations and select the preferred Supplier on the outcome of the negotiations. The selection in such cases shall be at the sole discretion of AMC*

### **C. GENERAL:**

1. Tender must be submitted in English Language only. Incomplete/ telegraphic or conditional proposal (s) is not acceptable.
2. All terms and conditions of this tender must be accepted in full and in taken there of the bidder must sign at the bottom of each page of the document and submit the same along with technical bid. The product for which tender is to be submitted should comply with the technical specification as per Annexure-III.
3. The quantity of machineries required to be purchased is subject to alteration without prior information.
4. Delivery should be made within 60 (Sixty) days time of placing the purchase order.
5. Canvassing in any manner is strictly prohibited. The same will lead to rejection of the Proposal.
6. In case of any correction or overwriting made by the Bidder in the rates offered, it should be signed & sealed by the Bidders; otherwise Proposals are liable for rejection.
7. An agreement will be executed with the selected bidder.
8. Proposal received after due date & time will not be considered. If due to any reason the due date is declared as a holiday the tender will be opened on next working day at the same time.
9. In case of supply of any defective item or substandard item(s), the item(s) will be rejected & it will be the responsibility of the supplier for taking back & replacing the rejected item at their own cost. In case of non-lifting of such rejected item(s) within a reasonable time offered by the AMC, it will have the right to suitably dispose of the same and forfeit the amount.
10. Any clarification on the technical specification and commercial terms and conditions may be clarified in writing from AMC.
11. AMC (Agartala Municipal Corporation) reserves the right to reject any Proposal, if: (a) any time, a material misrepresentation is made or discovered; or (b) Supplier does not respond promptly and diligently to requests for supplemental information required for the evaluation of the Proposal.
12. The bidder shall be a registered manufacturer or authorized distributor/dealer with ISO certificate confirming the design and manufacturer of similar kind of equipments.
13. Warranty shall have to be provided against manufacturing defects for a minimum period of 18 (Eighteen) months.
14. In the event of acceptance of the preferred Supplier with or without negotiations, AMC shall declare the preferred Supplier as the successful Supplier for the item. Notwithstanding anything contained in this Proposal document, AMC reserves the right to accept or reject any Proposal, or to annul the bidding process or reject all Proposals, at any time without any liability or any
