
Other detail information and terms and conditions will be available Executive Engineer Planning Division, AMC at Paradise Chowmuhani, City Centre, Agartala on all working days.

**TERMS AND CONDITIONS**

1. The agencies / firms who have already registered their names as vendors in any division of AMC need not require to apply.
2. Offer should be submitted supported with necessary valid registration documents of ITC/PTC clearance certificate etc. along with GST registration.
3. Materials should be supplied in good condition as per specification at the respective work sites of AMC area as per direction of the Engineer-In- Charge.
4. Rate of offer should be inclusive of all Taxes, GST etc. as applicable.
5. Enlisted Empanelled vendors must be valid for 12(twelve) months and the rate is FIRM for entire contract period from the date of issue of supply order.
6. The contract period may be extended for further period on satisfactory performance by the supplier/agency if necessary on mutual settlement of rate & terms & conditions based on reasonable ground.
7. Authority of AMC reserves the right to accept or reject any quotation without assigning any reason.
8. After selection process the eligible suppliers will have to deposit an amount of Rs. 5000/- (Rupees Five thousand) only as security money through "Demand draft" on any scheduled Bank having branch in Agartala in favour of "Agartala Municipal Corporation" which will be refunded in due course of time.
9. Terms and conditions if not specified, will be at par State Govt. rules or as per absolute decision of the Municipal Authority.
