TERMS AND CONDITIONS

1. The offer of EOI must be properly sealed with wax or self-adhesive tape before submission and should reach in properly sealed and good condition.
2. The agency should produce copy of valid ITC/PTC clearance along with the submitted offer.
3. The rate/amount accepted is 'FIRM' during the entire contract period and is inclusive of all taxes, duties and other charges. The breakup of rate to be quoted should be clearly mentioned including carriage charges at Agartala Municipal Corporation area.
4. The site for supply of materials will be provided and intimated within AMC area in due course of time.
5. The formal agreement will have to be executed within 7 (seven) days from the date of issue of supply order.
6. Supply of materials as per specification should be completed within 30 (thirty) days from the day of issue of supply order.
7. Statutory deduction in respect of Tax, Vat etc. as applicable will be done from the bill.
8. Prior information of the exact day of reaching of materials at Agartala Municipal Corporation store should have to be given well in advance.
9. Materials should be supplied in good condition. If any damage occurs during transportation or before delivery it should be replaced by you at your risk and cost.
10. Application fee for submission of EOI will be **Rs. 1,000/- (Rupees one thousand) only** (Non-refundable) in the form of demand draft in favour of Agartala Municipal Corporation payable at Agartala.
11. After selection process, the eligible supplier will have to deposit an amount of **Rs. 10,000/- (Rupees ten thousand) only** as security money through “Demand draft: on any scheduled Bank having branch in Agartala in favour of Agartala Municipal Corporation, which will be refunded after 180 days if no defects in the materials are found.
12. The payment will be made on full supply of materials and on production of bills.
13. All supplied items should have a guarantee of 1 (one) year from the date of final acceptance by the purchase and if any manufacturing defect is detected within this period this should be replaced / repaired by the supplier at their cost.
14. Materials are to supplied within stipulated delivery period failing of which deposited security money shall be forfeited in full.

15. All terms and condition are to be accepted unconditionally. Any conditional offer will summarily be rejected.
16. Department reserves the right to accept or reject any EOI including the lowest one without assigning any reason.
