The Buyer / Auctioner shall have to submit security money in the shape of deposit at call from any schedule Bank of India guaranteed by the RBI **in favour of Agartala Municipal Corporation payable at Agartala**. Deposited security money of unsuccessful Auctioner(s) except first & second highest Auctioner will be released within 07 (seven) days from the opening of sealed auction rate. The security money of successful Auctioner will be released after completion of job in all respect.
4. The auction rate quoted by the Buyer(s) / Auctioneer(s) in figures and in words.
5. If any Buyer(S) / Auctioner(s) withdraws his auction paper before preparation of Comparative Statement then the AMC authority shall, without prejudice to any other right or remedy, be at liberty to forfeit the security money @ 50%.
