IV. The EOI should fulfill the following terms and conditions:-

1. The quoted rate will include the cost of equipments including laying of cable by the vendor and rate for annual maintenance contract of the system
2. Rate should be quoted both in figures and words indicating rate of Sales Tax/VAT, if any separately.
3. Professional tax clearance/ Firm Registration/VAT Registration/ Sale tax and VAT clearance Certificates of the Firm are to be enclosed with the tender documents.
4. Payment will be made by Society for Management of City Centre, Agartala after completion of supply and installation.
5. The undersigned reserves the right to accept or reject any quotations without assigning any reasons.
6. The accepted rate shall remain valid at least for 12 (twelve) months from the date of quotations.
7. The vendors participating in the tender process should have previous experience and capacity to deliver.
8. After awarding the work to the selected firm/agency an agreement will have to be executed within 15 (fifteen days between the selected firm/agency and the Society.


9. The recording facility has to be provided by the vendors with 15 days recording back-up.
10. The latest software has to be provided by the vendor.
11. The vendor will also provide training to the monitoring personnel to man the control panel.
12. In any case, any problem has to be attended by the vendor within 24 hours of reporting of the problem. A log book will be maintained to track the problems, if any.
13. Necessary Power supply to the system will be provided by the Society.
14. On site warranty will be provided by the tenderer for 2 (two) years for any defect on installation/supplied equipments.
15. The tenderer will deposit a security money of Rs 20000.00 (Rupees twenty thousand) only in the shape of demand draft in favour of "**Society for Management of City Centre**" from any nationalized bank along with tender documents which will be refunded to the unsuccessful bidders on completion of the tender process.
16. The specification which is quoted in the tender documents cannot be deviated in any circumstances.
17. In case of any inherent defects found after installation, the materials should be liable to be replaced by the agency.
18. Society for Management of City Centre reserves the right to cancel the tender process at any time without assigning any reasons
