2. Materials should be supplied in good condition as per specification at the respective work sites of central Zone area of AMC as per direction of the Eng-in-charge.
3. Approved rates of materials as displayed in the web site is inclusive of all applicable Taxes, Cess etc.
4. Empanelled / selected vendors shall be valid for supply of materials for 12 (twelve) months and the rate is FIRM for entire contract period from the date of issue of supply order. The contract period may be extended for further period on satisfactory performance by the supplier/ agency if necessary on mutual settlement of rate & terms & condition based on reasonable ground.
5. AMC reserves the right to accept or reject any quotation without assigning any reason.

After selection process, the eligible suppliers will have to deposit an amount of **Rs. 5,000/- (rupees five thousand) only** as security money through "Demand Draft" on any scheduled bank having branch in Agartala in favour of Agartala Municipal Corporation, which will be refunded in due course of time.
