### Introduction:

The Urban Development Department, Govt. of Tripura has decided to procure latest machineries and equipment for improvement of waste collection and transportation activities in Nagar Panchayat/Municipal Council in the state.

### Eligibility Criteria:

*The bidder(s) who meet(s) the following may only apply:*

1. The bidder must be based in India and should be manufacturer equipment intended for supply. For item no 1 the authorized dealer can participate on behalf of the manufacturer.
2. ISO: 9001-2008 certification.
3. Minimum Turnover Rs. 5 Crore in average for the last three years.
4. Minimum supply of such related equipments: Minimum 5 nos. in municipal / Govt, with minimum supply of 4 nos equipment in any one municipal /Govt in India and have to provide satisfaction letter from at least 5 municipals /Govt.
5. The bidder should have adequate service facility and technical man power to provide necessary after sale services within 48 hours.
6. Company with maximum warranty will be given preference.
7. The Manufacture should ensure they are not BLACK LISTED by anybody earlier. If yes should explain the resigns.

### Submission:

The tenders should be submitted in a sealed envelope for each items separately mentioning name of work and item number by hand or post to the address shown above. Each sealed envelope should contain 03 separate sealed envelopes superscribed, "Technical Bid", "Price Bid" & "EMD-Application Fees" respectively.

(A) Contents of the envelope superscribed as "Technical bid":

- ✓ Organizational profile
- ✓ Technical Specification duly filled in strictly as per Annexure – II which must have the minimum dimensions & requirement given in the technical specification shown in the document.
- ✓ Offered Product details with Technical Specifications.
- ✓ Valid VAT / Sales tax clearance certificate.
- ✓ Downloaded tender documents with signatory of authorized signatory in each page.
- ✓ Balance sheets and profit and loss accounts for last 3 years.
- ✓ Documentary evidences with respect to eligibility criteria shown above.
- ✓ Affidavit of non blacklisting from any Govt. department.

(B) Contents of envelop superscribed "Price bid":

- Price bid in the prescribed format given in Annexure: III
- Maintenance cost for 01 year period separately shall have to be given for the tendered items.

(C) Contents of envelop superscribed "EMD-Application Fees": Earnest Money Deposit as mentioned against each item & Application fees Rs10,000/-only for each item in the form of Demand Draft of Nationalized Bank in favor of Agartala Municipal Corporation, payable at Agartala.

### Opening & Evaluation

"Technical Bid" shall be opened at the time & date mentioned in the press notice in the presence of Bidder(s), who intend(s) to remain present. "Price Bid" the technically qualified bidders after evaluation shall be opened only. The date for opening of Price bid shall be communicated subsequently. If necessary, the firms may be called for Technical Presentation (PPT). Technical Evaluation will be done as per Format in the Annexure -I.

### Terms & Condition

1. Tenders must be submitted in English Language only. Incomplete/ telegraphic or conditional tenders are not acceptable. Canvassing in any manner is strictly prohibited. The same will lead to rejection of the tender.
2. The quantity of machineries required to be purchased is subject to alteration without prior information.
3. Proof in support of having authorized dealer / sales, service centre / **Office in Agartala should been closed**. If the bidder does not have a service centre or office in Agartala, he shall submit an undertaking along with the tender for opening of the same in the state before commencement of work, if contract is awarded. Or he must assured after sale service within 48 hours.
4. Tender received after due date & time will not be considered. If due to any reason the due date is declared as a holiday the tenders will be opened on next working day at the same time.
5. In case of supply of any defective machine, material or substandard material, the materials will be rejected & it will be the responsibility of the supplier for taking back & replacing the rejected materials at their own cost. In case of non-lifting of such rejected materials within a reasonable time offered by the office, it will have the right to suitably dispose of the same and forfeit the amount.
6. Any clarification on the technical specification and commercial terms and conditions may be clarified in writing from AMC.
7. Any condition in regard to financial aspects, payments, terms of rebate etc beyond the prescribed financial terms of AMC will make the bidder invalid. Therefore it is in the interest of the Bidder not to write anything extra in the Price Bid except the price.
8. As part of the evaluation of the quotation, AMC may request the bidder to submit clarifications. The format for quoting the Financial/Price Bid should be as per Annexure-III.
9. In case there are two or more bidder(s) quoting the same price for a particular item, AMC may in such case, call all such bidders(s) for negotiations and select the preferred bidder(s) on the outcome of the negotiations. The decision in such cases shall be at the sole discretion of AMC. In the event of acceptance of the preferred bidder(s) with or without negotiations, AMC shall declare the preferred bidder as the selected bidder.
10. Notwithstanding anything contained in this tender document, AMC reserves the right to accept or reject any quotation, or to annul the bidding process or reject all quotations, at any time without any liability or any obligation for such rejection or annulment, without assigning any reasons thereof. No reason will be assigned by AMC for this and will be binding on the Bidders.
11. Inspection: Inspection shall be carried out at the cost of the bidder. If require third party inspection may be conducted by a authorized agency of Government of India.
12. Successful bidder will be given a "Letter of Intent" to appear at Agartala to formulate the contract agreement after signing of which by either party final work order will be given to the successful bidder.
