

TERMS OF REFERENCE

INTRODUCTION

Traffic signaling system will be introduced in the city. Therefore it is decided to make proper marking in the junctions where signals will be installed and as well as for road marking across the city

ELIGIBILITY CRITERIA

The bidder(s) who meet(s) the following may only apply:

1. The bidder must be based in India and should be a manufacturer/authorized dealer of the tool / equipment intended for supply.
2. NSIC/ISO: 9001-2008 certification.
3. Minimum Turnover Rs. 50 Lakhs in average for the last three years.
4. Minimum supply of such related equipments: Minimum 25 in the last 03 years.
5. The bidder should have adequate service facility and technical man power to provide necessary after sale services within 48 hours.

SUBMISSION

The tenders should be submitted in a sealed envelope superscripted as "Tender for Road Marking Machine" by hand or post to the address shown above. This sealed envelope should contain 03 separate sealed envelopes superscribed, "Technical Bid", "Price Bid" & "EMD-Application Fees" respectively.

(A) Contents of the envelope superscribed as "Technical bid":

- ✓ Organizational profile
- ✓ Technical Specification duly filled in strictly as per Annexure – II which must have the minimum dimensions & requirement given in the technical specification shown in the document.
- ✓ Offered Product details with Technical Specifications.
- ✓ Valid GSTN
- ✓ Downloaded tender documents with signatory of authorized signatory in each page.
- ✓ Balance sheets and profit and loss accounts for last 3 years.

(B) Contents of envelop superscribed "Price bid":

- Price bid in the prescribed format given in Annexure: III
- O & M cost for 01 year period separately shall have to be given for the tendered items.

(C) Contents of envelop superscribed "EMD-Application Fees":

- Earnest Money Deposit & Application fees in the form of Demand Draft of Nationalized Bank in favor of Agartala Municipal Corporation, payable at Agartala.

OPENING & EVALUATION

- Technical Bid shall be opened at the time & date mentioned in the press notice in the presence of Bidder(s), who intend(s) to remain present.
- Price Bid of the technically qualified bidders who scores minimum 50 % of the total weightage that is 250 will be opened. Technical evaluation will be done as per the format shown Annexure -I.
- The date for opening of Price bid shall be communicated in due course of time the presence of Bidder(s), who intend(s) to remain present.
- The lowest bidder (L1) in the Price Bid will be awarded work order.

TERMS & CONDITION

1. Tenders must be submitted in English Language only. Incomplete/ telegraphic or conditional tenders are not acceptable. Canvassing in any manner is strictly prohibited. The same will lead to rejection of the tender.
2. Quantities required may increase or decrease.
3. Proof in support of having authorized dealer / sales, service centre / Office in Agartala should be enclosed. If the bidder does not have a service centre or office in Agartala, he shall submit an undertaking along with the tender for opening of the same in the state before commencement of work, if contract is awarded. Or he must assured after sale service within 48 hours.
4. Tender received after due date & time will not be considered. If due to any reason the due date is declared as a holiday the tenders will be opened on next working day at the same time.
5. In case of supply of defective material or substandard material, the materials will be rejected & it will be the responsibility of the supplier for taking back & replacing the rejected materials at their own cost. In case of non-lifting of such rejected materials within a reasonable time offered by the office, it will have the right to suitably dispose of the same and forfeit the amount.
6. Any clarification on the technical specification and commercial terms and conditions may be clarified in writing from AMC.
7. Any condition in regard to financial aspects, payments, terms of rebate etc beyond the prescribed financial terms of AMC will make the bidder invalid. Therefore it is in the interest of the Bidder not to write anything extra in the Price Bid except the price.
8. As part of the evaluation of the quotation, AMC may request the bidder to submit clarifications. The format for quoting the Financial / Price Bid should be as per Annexure-III.
9. In case there are two or more bidder(s) quoting the same price for a particular item. AMC may in such case divide the quantity in equal among the bidders and accordingly s/o will be issued.
10. AMC reserves the right to accept or reject any quotation, or to annul the bidding process or reject all quotations, at any time without any liability or any obligation for such rejection or annulment, without assigning any reasons thereof.
11. Inspection: Inspection of the items if required may be carried out at the cost of the bidder.
12. Delivery: Delivery shall have to be made within 30 days on placement of the Supply order.
13. Warranty: The equipment supplied under this tender should be warranted against any manufacturing defect or bad workmanship at least for a period of 2 (Two) years for all items from the date of receipt.
