EMD in the mode of DD (Nationalized Bank) only shall have to be separately submitted as mentioned above against Group Only in favour of Agartala Municipal Corporation, Agartala. **EMD will be exempted as per the norms of Central/State Govt. against production of relevant documents.**

Tender fees is non refundable and submitted in the mode of the mode of DD (Nationalized Bank) only in favour of Agartala Municipal Corporation, Agartala. It is common for all the groups or any of the Groups.

Opening & Evaluation of the Bid

Commercial terms & Condition:

(i) The offer should indicate the unit cost of the equipment and taxes & duties separately. The unit cost must be inclusive of packing, forwarding, loading & unloading charges, cost of insurance and transportation upto AMC Agartala.

(ii) Sales Tax & Duties etc.: All Taxes and duties as prescribed both under Central and State Government Sales Tax rules would be applicable.

(iii) Earnest Money Deposit:

- Earnest money deposit as mentioned above shall have to be deposited in favour of Agartala Municipal Corporation along with the Technical bid without which the bid will be declared informal.
