

### **Introduction:**

The authority of AMC has decided to procure Tri-Cycle Rickshaw with load body of 0.50 Cum capacity having tipping arrangement to unload garbage directly to containers and compactors for utilization in various municipal job especially door to door garbage collection etc.

### **Eligibility Criteria:**

*The bidder(s) who meet(s) the following may only apply:*

1. The bidder must be based in India and should be a manufacturer.
2. ISO certification.
3. NSIC/SSI registration.
4. Minimum Turnover Rs. 1 Crore in average for the last three years.

### **Submission:**

The tenders should be submitted in a sealed envelope superscripted as "Tri-Cycle Rickshaw with load body of 0.50 Cum capacity having tipping arrangement to unload garbage directly to container and compactors" by hand or post to the address shown above. This sealed envelope should contain 03 separate sealed envelopes superscribed, "Technical Bid", "Price Bid" & "EMD-Application Fees" respectively.

(A) Contents of the envelope superscribed as "Technical bid":

- ✓ Organizational profile
- ✓ Technical Specification duly filled in conformity with the technical specification mentioned in this document.
- ✓ Valid VAT / Sales tax clearance certificate.
- ✓ Downloaded tender documents with signatory of authorized signatory in each page.
- ✓ Balance sheets and profit and loss accounts for last 3 years.
- ✓ Documentary evidences with respect to eligibility criteria shown above.

(B) Contents of envelop superscribed "Price bid":

- Price bid in the prescribed format given in Annexure: III
- O & M cost for 01 year period separately shall have to be given for the tendered items.

(C) Contents of envelop superscribed "EMD-Application Fees":

- Earnest Money Deposit Rs. 1,00,000/- & Application fees Rs. 1000/- in the form of Demand Draft of Nationalized Bank in favor of Agartala Municipal Corporation, payable at Agartala.  
(NSIC/SSI Registered firms will be exempted from EMD)

### **Opening & Evaluation**

"Technical Bid" shall be opened at the time & date mentioned in the press notice in the presence of Bidder(s), who intend(s) to remain present. "Price Bid" of the technically qualified bidders shall be opened only. The date for opening of Price bid shall be communicated subsequently. If necessary, the firms may be called for Power Point Presentation. Technical Evaluation will be done as per Format in the Annexure – I.

### Terms & Condition

1. Tenders must be submitted in English Language only. Incomplete/ telegraphic or conditional tenders are not acceptable. Canvassing in any manner is strictly prohibited. The same will lead to rejection of the tender.
2. The quantity of machineries required to be purchased is subject to alteration without prior information.
3. The bidder shall submit an undertaking through notary that service will be delivered within 48 hours during warranty period on receiving intimation from AMC.
4. Tender received after due date & time will not be considered. If due to any reason the due date is declared as a holiday the tenders will be opened on next working day at the same time.
5. In case of supply of any defective material or substandard material, the materials will be rejected & it will be the responsibility of the supplier for taking back & replacing the rejected materials at their own cost. In case of non-lifting of such rejected materials within a reasonable time offered by the office, it will have the right to suitably dispose of the same and forfeit the amount.
6. Any clarification on the technical specification and commercial terms and conditions may be clarified in writing from AMC.
7. Any condition in regard to financial aspects, payments, terms of rebate etc beyond the prescribed financial terms of AMC will make the bidder invalid. Therefore it is in the interest of the Bidder not to write anything extra in the Price Bid except the price.
8. As part of the evaluation of the quotation, AMC may request the bidder to submit clarifications. The format for quoting the Financial / Price Bid should be as per Annexure-III.
9. In case there are two or more bidder(s) quoting the same price for a particular item, AMC may in such case, call all such bidders(s) for negotiations and select the preferred bidder(s) on the outcome of the negotiations. The decision in such cases shall be at the sole discretion of AMC. In the event of acceptance of the preferred bidder(s) with or without negotiations, AMC shall declare the preferred bidder as the selected bidder.
10. Notwithstanding anything contained in this tender document, AMC reserves the right to accept or reject any quotation, or to annul the bidding process or reject all quotations, at any time without any liability or any obligation for such rejection or annulment, without assigning any reasons thereof. No reason will be assigned by AMC for this and will be binding on the Bidders.
11. Inspection: Inspection shall be carried out at the cost of the bidder.
12. Successful bidder will be given a "Letter of Intent" to appear at Agartala to formulate the contract agreement after signing of which by either party final work order will be given to the successful bidder.
13. Delivery: Delivery shall have to be made within 60 (days) days on placement of the supply order which will be issued after the contract agreement to be executed within 7 days on issuing LOI (letter of intent) to the lowest bidder.
14. Warranty: The equipment supplied under this tender should be warranted against any manufacturing defect or bad workmanship at least for a period of 2 (Two) years for all mechanical equipment from the date of receipt of the item.
15. The materials would be consigned to the Executive Engineer (Mech.), AMC.
16. Payment: (i) 70 % of the cost of the equipments (Including all taxes) shall be released on supply of the machineries and verification thereof as per the bills of materials. (ii) 20% cost of the supplied
