You are requested to attend this office to sign the formal agreement within 7 (seven) days from the date of receipt of the work order.


You are also requested to start the work at once in consultation with the Assistant Engineer, SD-Div-II, Agartala Municipal Corporation.

During execution of the work the following points shall have to be taken into account:


1. Work will be done under strict supervision.
