Information and instruction for bidders posted on website shall form part of bid document.

The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen in the website <https://tripuratenders.gov.in>

But the bid can only be submitted after uploading the mandatory scanned documents such as Demand Draft or Deposit – all receipt in favour of the **Agartala Municipal Corporation, Agartala** and other documents as specified.

Those contractors not registered on the website mentioned above, are required to get registered beforehand. This organization shall not remain committed to impart training on, online bidding process, as per details available on the website.

The intending bidders must have **valid digital signature** to submit the bid.

On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.


Contractor must ensure to quote rate for each item in case of item rate tenders. The column meant for quoting rate in figures appears in pink color and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells appearing that if any cell is left blank the same shall be treated as "(0)". Therefore, if any cell is left blank and no rate is entered by the bidder, rate of such item shall be treated as "0" (zero).

Bidders shall scan (in 100 dps scan resolution) all the required documents, into PDF format for uploading as part of Bid. Bill of Quantity (BOQ), which is the Rate quoting sheet in Ms-excel shall be downloaded, filled up properly and uploaded in the system after digital signing. The Bidder shall always open the BOQ sheet with Macros Enabled.
