
Terms and Condition:-

1. Offer should be submitted supported with necessary valid registration documents, Labour registration certificate, GST registration, valid enlistment (External), if not available must be submitted before issuing work order.
2. Rate of offer should be inclusive of all taxes, GST as applicable.
3. Enlisted empanelled agencies must be valid for 12(Twelve months) and the rate is FIRM for entire contract period from the date of issue of work order.
4. The contract period may be extended for further period on satisfactory performance by the agencies if necessary on mutual settlement of rate and terms and condition based on reasonable ground.
5. Authority of AMC reserves the right to accept or reject any quotation without assigning any reason.
6. After selection process the eligible agencies will have to deposit an amount of Rs. 1000.00 (Rupees one thousand) only as security money through Demand Draft on any scheduled Bank having branch in Agartala in favour of "Agartala Municipal Corporation" which will be refunded in due course of time.
7. Terms and Conditions if not specified will be as per state Government Rules or as per absolute decision of the Municipal Authority.
8. Schedule of work will be supplied to the intending Agency/Agencies from the office of the undersigned at free of cost.

Special Condition:-

1. Necessary payment will be made on production of authenticated bill after satisfactory completion of work and duly certified by the concerned Engineer-in-Charge.
